1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §251, sub-§1**, as repealed and replaced by PL 1983, c. 123,
3 is amended to read:

4 **1. Appointment.** The commissioner ~~shall be~~ is appointed by the ~~Governor state~~
5 ~~board~~, subject to review by the joint standing committee of the Legislature having
6 jurisdiction over education matters and to confirmation by the Legislature.

7 ~~A. The Governor shall include the chairman of the State Board of Education in the~~
8 ~~selection process and shall ensure that the state board has an opportunity to meet and~~
9 ~~interview the candidate or candidates.~~

10 ~~B. Within 10 days of meeting with the candidate or candidates, the state board shall~~
11 ~~deliver to the Governor its written appraisal of the strengths and weaknesses of the~~
12 ~~candidate or candidates.~~

13 ~~C. The Governor shall consider the appraisal of the state board prior to posting the~~
14 ~~nomination of a candidate.~~

24 **Sec. 4. 20-A MRSA §405, sub-§2**, as enacted by PL 1981, c. 693, §§5 and 8, is

26 **2. Appointing and advisory role.** The state board shall appoint and advise the
27 commissioner concerning matters contained in this Title.
