## An Act To Repeal Motor Vehicle Inspection Requirements

Reconstructable motor vehicle.</b> "Reconstructable motor vehicle" means a used motor vehicle that does not meet the inspection standards as set forth in Title 29-A, section 1751, and that is sold, offered for sale or negotiated for sale to a person other than another dealer for the purpose of transportation after repair or rebuilding.

Warranty content.</b> A dealer warrants that the motor vehicle the dealer sells, negotiates the sale of, offers for sale or transfers to a person other than another dealer has been inspected in accordance with met the inspection standards in Title 29-A, section 1751, and with the rules promulgated under that section: <u>1756</u> .
14 15	A. That the motor vehicle is in the condition and meets the standards required by that law and the rules; or
