14	Amend the resolve by striking out all of sections 1 and 2 and inserting the following:
15	Sec. 1. Secretary of State directed to examine the issue of a traditional
16 17	run-off election for Governor. Resolved: That the Secretary of State shall examine
17	the issue of holding a traditional run-off election in cases when each candidate for Governor receives less than 50% of the votes cast at the election. The Secretary of State
19	shall confer with the executive director of the Commission on Governmental Ethics and
20	Election Practices regarding the impact that traditional run-off elections may have on
21	campaign finance laws, including the Maine Clean Election Act; and be it further
22	Sec. 2. Report. Resolved: That the Secretary of State shall submit a report
23	concerning the issue of a traditional run-off election for Governor and any recommended
24	legislation to the Joint Standing Committee on Veterans and Legal Affairs by January 31,
25	2012.'
26	SUMMARY
27	This amendment is the minority report of the committee. It clarifies that the
28	Secretary of State is required to examine traditional run-off elections and requires
29	consideration of the impact of traditional run-off elections on the campaign finance laws,
30	including the Maine Clean Election Act.
