#### **Fiscal Detail and Notes**

This legislation proposes to issue free hunting, trapping and fishing licenses and permits to nonresident wartime veterans 80 years of age or older and would result in a reduction in General Fund revenues of \$56,000 beginning in fiscal year 2011-12
