HOUSE AMENDMENT "H" to COMMITTEE AMENDMENT "B" to H.P. 418, L.D. 535

2. It provides that a federally recognized Indian tribe other than the Penobscot Nation, the Houlton Band of Maliseet Indians and the Aroostook Band of Micmacs may conduct high-stakes beano up to 100 days per year.

3. It permits the Passamaquoddy Tribe to operate high-stakes beano in the City of Calais if approved by the city.

4. It removes from the committee amendment authority to conduct electronic beano.

5. It removes from the committee amendment the appropriations and allocations section.

Fiscal Detail and Notes

This legislation permits the Passamaquoddy Tribe to operate high-stakes beano in Calais, allows only the Passamaquoddy tribe to operate high-stakes beano 100 days per year and removes the authority to conduct electronic beano. The incremental fiscal impact related to the committee amendment removes the need for the Public Safety Inspector I position and related costs.
