COMMITTEE AMENDMENT "A" to S.P. 160, L.D. 568, Bill, "An Act To Create a Unified Early Childhood Education System in Maine"

Amend the bill by striking out the title and substituting the following:

12

**'Resolve, To Establish an Early Childhood Stakeholder Group'**

Amend the bill by striking out everything after the title and inserting the following:

14

**'Emergency preamble. Whereas,** acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** recent reductions in federal Medicaid funding and recent changes made to the Maine Department of Health and Human Services rules for MaineCare reimbursement may result in adverse implications for eligible children who are served by various early childhood programs delivered by human service agency programs and early childhood education programs in the public and private sector; and

**Whereas,** a unified early childhood system can result in a more efficient and effective use of limited public and private resources to provide critical early care and education services to children in the State; and

**Whereas,** the early childhood stakeholder group established by this resolve must convene at the earliest possible date in order to have sufficient time to complete its duties in time for reporting to the 125th Legislature; and

**Whereas,** in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

**Sec. 1. Early childhood stakeholder group; convening; staffing and technical assistance. Resolved:** That the Maine Children's Growth Council shall establish an early childhood stakeholder group, referred to in this resolve as "the stakeholder group," within existing budgeted resources. The Maine Children's Growth

1 Council shall appoint one of its members to serve as the chair of the stakeholder group  
2 and shall convene the stakeholder group; and be it further

3 **Sec. 2. Stakeholder group membership. Resolved:** That the stakeholder  
4 group consists of at least 15 members, including the chair and the following persons,  
5 appointed by the Maine Children's Growth Council as set out in this section:

- 6 1. A parent who is a member of the Child Care Advisory Council;
- 7 2. A parent who has a child who participates in a Head Start program in the State;
- 8 3. A parent who is a member of the Maine Parent Federation;
- 9 4. A parent who is a member of Maine Families;
- 10 5. A parent who has a child who participates in a Child Development Services  
11 System program in the State;
- 12 6. A parent who has a child who participates in a prekindergarten program operated  
13 by a public school in the State;
- 14 7. A member of the Maine Developmental Disabilities Council;
- 15 8. A member of the Maine Roads to Quality;
- 16 9. A regional site director from the Child Development Services System;
- 17 10. A Head Start director from the Maine Head Start Directors Association;
- 18 11. A family child care provider in the State;
- 19 12. A home visiting nurse provider in the State;
- 20 13. A public prekindergarten teacher in the State;
- 21 14. An early intervention therapeutic service provider in the State; and
- 22 15. Representatives of other interested parties in the State as determined by the  
23 Maine Children's Growth Council; and be it further

24 **Sec. 3. Technical assistance. Resolved:** That, upon the request of the chair of  
25 the stakeholder group, the Department of Education and the Department of Health and  
26 Human Services, referred to in this resolve as "the departments," shall, within existing  
27 budgeted resources, provide technical assistance to the stakeholder group; and be it  
28 further

29 **Sec. 4. Duties. Resolved:** That the stakeholder group shall determine the  
30 strengths and weaknesses of the State's current programs for children from birth to 5  
31 years of age, including but not limited to the following programs:

- 32 1. The Child Development Services System;
- 33 2. The public prekindergarten programs operated by public schools in the State; and
- 34 3. Programs within the Department of Health and Human Services, Bureau of Child  
35 and Family Services, including:
  - 36 A. The maternal and child health program;
  - 37 B. The early childhood program;

- 1 C. The child welfare program;
- 2 D. The child behavioral health services program;
- 3 E. The Temporary Assistance for Needy Families program; and
- 4 F. The child care licensing program.

5 The stakeholder group's goal is to make recommendations to improve the early  
6 childhood system's efficacy and efficiency; and be it further

7 **Sec. 5. Report. Resolved:** That, no later than December 15, 2011, the  
8 stakeholder group shall submit a report to the Joint Standing Committee on Education  
9 and Cultural Affairs and the Joint Standing Committee on Health and Human Services  
10 that includes the findings of the stakeholder group, the options and alternatives developed  
11 by the stakeholder group and any analysis by the departments of those options and  
12 alternatives. The report may include suggested legislation. The Joint Standing  
13 Committee on Education and Cultural Affairs and the Joint Standing Committee on  
14 Health and Human Services may each submit a bill to the Second Regular Session of the  
15 125th Legislature related to the report of the stakeholder group.

16 **Emergency clause.** In view of the emergency cited in the preamble, this  
17 legislation takes effect when approved.'

18 **SUMMARY**

19 This amendment replaces the bill with a resolve requiring the Maine Children's  
20 Growth Council to establish and convene a stakeholder group to identify options and  
21 alternatives to improve the efficacy and efficiency of Maine's early childhood system.  
22 The Department of Education and the Department of Health and Human Services are  
23 required to provide technical assistance to the stakeholder group. The stakeholder group  
24 is required to submit a report to the Joint Standing Committee on Education and Cultural  
25 Affairs and the Joint Standing Committee on Health and Human Services that includes  
26 the findings of the stakeholder group, including options and alternatives developed by the  
27 stakeholder group and any analysis by the departments of those options and alternatives.  
28 The report may include suggested legislation.
