2 3	Sec. 1. 20-A MRSA §6552, as amended by PL 2009, c. 614, §§2 and 3, is repealed and the following enacted in its place:
4	§6552. Firearms
5	1. Prohibition. A person may not:
6 7	A. Possess a firearm on public school property or the property of an approved private school;
8 9	B. Display a firearm on public school property or the property of an approved private school; or
10 11	C. Discharge a firearm within 500 feet of public school property or the property of an approved private school.
12	2. Exceptions. The provisions under subsection 1 do not apply to the following.
13 14	A. The prohibition on the possession, display and discharge of a firearm does not apply to law enforcement officials.
15 16 17	B. The prohibition on the possession and display of a firearm does not apply to the following persons, if the possession and display is authorized by a written policy adopted by the school board:
18 19 20 21	(1) A person who possesses and displays an unloaded firearm for use in a supervised educational program approved and authorized by the school board and for which the school board has adopted appropriate safeguards to ensure student safety; and
22 23 24 25	(2) A person who possesses or possesses and displays an unloaded firearm that is stored inside a locked vehicle in a closed container, a zipped case or a locked firearms rack while the person is attending a hunter's breakfast or similar event that:
26 27	(a) Is held during an open firearm season established under Title 12, Part 13 for any species of wild bird or wild animal;
28	(b) Takes place outside of regular school hours; and
29	(c) Is authorized by the school board.
30 31 32 33 34	C. The prohibition on possession, display and discharge of a firearm does not apply to a person possessing a firearm at a school-operated gun range or a person discharging a firearm as part of a school-sanctioned program at a school-operated gun range if the gun range and the program are authorized by a written policy adopted by the school's governing body.
35	3. Penalty. This subsection applies to violations of subsection 1.
36	A. A person who violates subsection 1, paragraph A commits a Class C crime.
37	B. A person who violates subsection 1, paragraph B commits a Class B crime.

Be it enacted by the People of the State of Maine as follows:

1	C. A person wno violates subsection 1, paragraph C commits a Class E crime.
2	SUMMARY
3	This bill increases the offense of possessing a firearm on public school property or
4	the property of an approved private school from a Class E crime to a Class C crime and
5	provides that the offense of displaying a firearm on public school property or the property
6	of an approved private school is a Class B crime
