10	Regarding the Milk Handling Fee"
11	Amend the bill by striking out all of section 3 and inserting the following:
12	'Sec. 3. 36 MRSA §4903 is enacted to read:
13	§4903. Credit or refund for fee paid for packaged milk
14	1. Credit or refund allowed. A handler or handler's designee may claim a credit or
15	refund for a fee paid pursuant to this chapter on packaged milk that is subsequently
16 17	exported from this State by a customer of the handler or the handler's designee for sale out of state.
18	2. Handler's claim for credit or refund. A handler claiming a credit or refund
19	under subsection 1 must file a claim with the assessor. The credit or refund must be
20	claimed on the report required under section 4902, subsection 5. A handler may not claim
21	a credit or refund under this section for any sales occurring before October 1, 2011.
22	3. Designee's claim for credit or refund. A handler's designee claiming a credit or
23	refund under subsection 1 must file a claim with the assessor. The credit or refund must
24 25	be claimed on a report required under section 4902, subsection 5 or other form as prescribed by the assessor. A handler's designee may not claim a credit or refund under
23 26	this section for any sales occurring before October 1, 2011.
27	SUMMARY

28	This amendment specifies that a credit or a refund may be claimed. It clarifies that
29 20	the refund or credit may be claimed when the milk handling fee is paid on packaged milk that is subsequently supported for out of state sale. It empiries that claims for and is on

This bill establishes a credit or refund on the milk handling fee paid on milk that is subsequently exported for out of state sale. It also imposes a handling fee on 20-quart containers of packaged milk. It is expected that the loss of revenue related to refunds of the milk handling fee will be offset by assessing the fee on 20-quart containers.
