#### Fiscal Detail and Notes

Provides an appropriation of \$283,217 in 2011-12 and \$377,622 in 2012-13 for additional MaineCare long-term care services costs as more people would qualify for MaineCare services as a result of removing the requirement for a written agreement governing the paid services provided by a relative and from removing the presumptions regarding the purpose of paying for services and certain transfers. Assumes an additional 15 persons would qualify as a result of the resolve's requirements.
