9 COMMITTEE AMENDMENT "A" to H.P. 617, L.D. 821, Bill, "An Act To 10 Transfer Responsibility for the Enforcement of Liquor Laws to the Department of 11 Administrative and Financial Services, Bureau of Alcoholic Beverages and Lottery 12 Operations"

Amend the bill by striking out the title and substituting the following:

14 'Resolve, To Study the Feasibility of Transferring Administration of the Liquor
15 Laws to the Bureau of Alcoholic Beverages and Lottery Operations'

16 Amend the bill by striking out everything after the title and before the summary and 17 inserting the following:

18 'Sec. 1. Bureau of Alcoholic Beverages and Lottery Operations and the 19 division of liquor licensing within the Department of Public Safety to 20 examine the feasibility of transferring the administration of the liquor laws. 21 **Resolved:** That the Director of the Bureau of Alcoholic Beverages and Lottery 22 Operations within the Department of Administrative and Financial Services or the 23 director's designee and the director of the division of liquor licensing within the 24 Department of Public Safety shall examine the feasibility of transferring the 25 administration of the laws governing alcoholic beverages from the division of liquor 26 licensing to the Bureau of Alcoholic Beverages and Lottery Operations. The directors 27 jointly shall issue a report to the Joint Standing Committee on Veterans and Legal Affairs 28 no later than February 1, 2012. The report must include a list of the responsibilities of the 29 division of liquor licensing and indicate which of those responsibilities requires the use of a sworn law enforcement officer. The report must consider staffing and personnel 30 31 changes and any cost savings that would be recognized as the result of transfer. The 32 report must include a list of statutory changes that would be necessary to facilitate the 33 transfer. The Joint Standing Committee on Veterans and Legal Affairs is authorized to 34 report out a bill to the Second Regular Session of the 125th Legislature based on the 35 findings of the report.'

SUMMARY

2 This amendment replaces the bill with a resolve directing the Director of the Bureau 3 of Alcoholic Beverages and Lottery Operations within the Department of Administrative 4 and Financial Services and the director of the division of liquor licensing within the 5 Department of Public Safety to issue a report to the Joint Standing Committee on 6 Veterans and Legal Affairs examining the feasibility of transferring administration of the 7 liquor laws from the division of liquor licensing to the Bureau of Alcoholic Beverages 8 and Lottery Operations. The resolve authorizes the committee to report out a bill to the 9 Second Regular Session of the 125th Legislature.
