20	3. Two members appointed by the Chief Justice of the Supreme Judicial Court;
21	4. One member appointed by the Attorney General; and
22 23	5. One representative of the Maine Trial Lawyers Association designated by the Maine Trial Lawyers Association; and be it further'

Resolved: That the commission shall seek the participation of the Maine State Bar Association, the Maine Prosecutors Association, Pine Tree Legal Assistance, the Maine Commission on Indigent Legal Services and the Maine Association of Criminal Defense Lawyers and may seek the participation of any other individuals or organizations whose participation or input may be helpful; and be it further

SUMMARY

This amendment reduces the size of the Commission To Study Priorities and Timing of Judicial Proceedings in State Courts and revises the membership to include 3 Senators, instead of 2 as proposed by the resolve. It deletes as required members representatives of the Maine State Bar Association, the Maine Prosecutors Association and Pine Tree Legal Assistance. Instead, this amendment requires the commission to seek the participation of these organizations as well as the Maine Commission on Indigent Legal Services and the Maine Association of Criminal Defense Lawyers. It also authorizes the commission to seek the participation of any other individuals or organizations.

The general operating expenses of this study are projected to be \$4,490 in fiscal year 2011-12. The Legislature's proposed budget includes \$10,000 in fiscal year 2011-12 for legislative studies. Whether that amount is sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature.
