#### **Fiscal Detail and Notes**

The bill includes a General Fund appropriation of \$73,341 in fiscal year 2011-12 and \$96,949 in fiscal year 2012-13 to support the cost of one Ombudsman position within the Judicial Branch. It also includes a General Fund appropriation of \$137,390 in fiscal year 2011-12 and \$185,430 in fiscal year 2012-13 for one Ombudsman position and one Office Associate position within the Department of Corrections.
