Amend the amendment in Part A in section 4 in paragraph I in subparagraph (5) in the 4th line (page 3, line 37 in amendment) by inserting after the following: " $\underline{1}$ " the following: 'to the extent permitted by the federal Affordable Care Act'

Amend the amendment in Part A in section 5 by striking out all of paragraph C (page 4, lines 16 to 22 in amendment) and inserting the following:

'C. A carrier may vary the premium rate due to <u>occupation and industry</u>, family membership, smoking status, participation in wellness programs and group size. The superintendent may adopt rules setting forth appropriate methodologies regarding rate discounts for participation in wellness programs and rating for occupation and <u>industry and group size</u> pursuant to this paragraph. Rules adopted pursuant to this paragraph are routine technical rules as defined in Title 5, chapter 375, subchapter H-A 2-A.'
