| 4 5 | <u>1. Definitions.</u> As used in this section, unless the context otherwise indicates, the following terms have the following meanings. |
| 6 7 | A. "Affiliated" means a relationship in which one entity owns 100% of the ownership interest in the hospital and the long-term care facility or nursing facility. |
| 8 9 | B. "Hospital pharmacy" means a facility that is owned by and located in a hospital and is engaged in dispensing, delivering or distributing prescription drugs. |
| 10 | C. "Long-term care facility" has the same meaning as in section 7852, subsection 9. |
| 11 | D. "Nursing facility" has the same meaning as in section 1812-A. |
| 12 13 | E. "Prescription drug" has the same meaning as in Title 32, section 13702-A, subsection 30. |
| 14 15 16 17 | 2. Scope of services. A hospital pharmacy may dispense prescription drugs to a person who is a patient in the hospital that owns the pharmacy and to a person who is receiving health care services in a nursing facility or a long-term care facility that is affiliated with that hospital. |
| 18 19 | Sec. 2. 32 MRSA §13702-A, sub-§24, as enacted by PL 2007, c. 402, Pt. DD, §2, is amended to read: |
| 20 | 24. Pharmacy. "Pharmacy" means: |
| 21 22 23 | A. Any pharmacy or drug outlet located in a retail store, mail order business, free clinic or rural health center with facilities located in this State that is engaged in dispensing, delivering or distributing prescription drugs; or |
| 24 25 26 | B. Any mail order prescription company, or wholesaler, with facilities located in this State or doing business in this State that is engaged in dispensing, delivering or distributing prescription drugs. |
| 27 28 | "Pharmacy" does not include a hospital pharmacy as defined in Title 22, section 1832, subsection 1, paragraph B. |
| 29 | SUMMARY |
| 30 31 32 33 34 | This bill provides that a pharmacy that is owned by and located in a hospital may dispense prescription drugs to a person who is a patient in that hospital and to a person who is receiving health care services in a nursing facility or a long-term care facility that is affiliated with that hospital. It clarifies that the definition of "pharmacy" in the Maine Pharmacy Act does not include a hospital pharmacy. |
