HOUSE AMENDMENT "H" to COMMITTEE AMENDMENT "A" to H.P. 1044, L.D. 1418, Bill, "An Act To Allow Table Games at a Facility Licensed To Operate Slot Machines on January 1, 2011"

Amend the amendment in section 10 in subsection 2-C in the first paragraph in the 3rd line (page 5, line 42 in amendment) by striking out the following: "16%" and inserting the following: '18%'

Amend the amendment in section 10 in subsection 2-C by striking out all of paragraphs C and D (page 6, lines 9 to 15 in amendment) and inserting the following:

16 'C. Two percent of the net table game income must be forwarded directly to the
17 municipality in which the table games are located;

18D. Two percent of the net table game income must be deposited into an account held19by the board for distribution to charitable nonprofit organizations that were eligible to20conduct beano games and games of chance in accordance with Title 17, chapters2113-A and 62. The account is nonlapsing and no distributions may be made from the22account before July 1, 2013; and

23E. Two percent of the net table game income must be forwarded to an organization24licensed to conduct high-stakes beano on January 1, 2010.'

## **Fiscal Detail and Notes**

This floor amendment proposes to dedicate 2% of net table game income from the Bangor facility to the Penobscot Nation. An Other Special Revenue Funds allocation will be required for payment to the Penobscot Nation for the additional revenue, estimated at \$106,240. The payment from the Bangor facility is contingent upon municipal approval of table games.
