4 5 6	C. A Class C license may be issued for the operation of a single vehicle or a combination of vehicles that does not meet the definition of Class A or Class B license.
7 8	A holder of a Class C license may, with an appropriate endorsement, operate all vehicles in that class.
9	A Class C license authorizes:
10 11 12 13 14	(1) A full-time or volunteer member of an organized municipal, state or federal fire department and a law enforcement officer who is a member of an organized municipal, state or federal law enforcement department to operate fire apparatus as described in 49 Code of Federal Regulations, Section 383.3 (2005) and to operate a commercial motor vehicle as a mobile command unit;
15	(2) A person to operate recreational vehicles for personal use;
16 17	(3) A person to operate commercial motor vehicles for military purposes as required in 49 Code of Federal Regulations, Section 383.3 (2005);
18 19	(4) A person to operate registered farm motor trucks bearing the letter "F" on the registration plate when the vehicle is:
20 21	 (a) Controlled and operated by a farmer, including operation by the farmer's employees or family members;
22 23	(b) Used to transport agricultural products, farm machinery or farm supplies to or from a farm;
24	(c) Not used in the operation of a common or contract motor carrier; and
25	(d) Used within 150 miles of the registered owner's farm;
26 27 28 29 30	(5) A person, employed by a city, town, county, district or other unit of local government created by or pursuant to law that has a total population of 3,000 individuals or less, to operate a commercial motor vehicle within the boundaries of that unit of local government for the purpose of removing snow or ice from a roadway by plowing, sanding or salting, if:
31 32	(a) The properly licensed employee who ordinarily operates a commercial motor vehicle for those purposes is unable to operate the vehicle; or
33 34	(b) The employing governmental entity determines that a snow or ice emergency exists that requires additional assistance; or
35 36 37	(6) A person to operate a truck registered as an antique automobile, regardless of weight or combination weight, provided the vehicle is used for noncommercial recreational purposes or purposes pursuant to section 101, subsection 3.

2	This bill provides that law enforcement officers in the State are allowed to operate a
3	commercial motor vehicle as a mobile command unit under the same allowance given to
4	firefighters and operators of fire apparatus.
