Amend the bill by striking out the title and substituting the following:

'Resolve, To Evaluate the All-payor Claims Database System for the State'

Amend the bill by striking out everything after the title and before the summary andinserting the following:

'Sec. 1. Creation of working group. Resolved: That the Department of Health and Human Services, referred to in this resolve as "the department," shall establish and convene a working group to evaluate options and actions available to improve the availability of and access to health care data and to examine the all-payor claims database system in the State; and be it further

Sec. 2. Membership. Resolved: That the Commissioner of Health and Human Services shall invite 17 persons to participate in the working group, as follows:

1. Two representatives of health insurance carriers;

2. Two representatives of health care providers, one member representing hospitals and one member representing physicians;

3. Two representatives of employers, one member representing a statewide health management coalition and one member representing a statewide chamber of commerce;

- 4. One representative of consumers;
- 28 5. One expert in both state and federal privacy laws;
 - 6. One representative of the Maine Health Data Organization;
- 30 7. One representative of the Maine Health Data Processing Center;
- 31 8. One representative of Onpoint Health Data;

Reviewing the current structures of and relationships among the Maine Health 14 Data Organization, the Maine Health Data Processing Center and Onpoint Health Data in 15 order to evaluate the timeliness and effectiveness of the data received; 16 2. Reviewing the current purposes and uses of the data and limitations on access to 17 the data and considering additional uses for the data and changes that might be necessary to achieve and facilitate additional uses; 18 19 3. Considering federal and state privacy and security laws regarding the use and 20 release of protected health information, including policy and technical changes needed to 21 allow increased access to protected health information and the feasibility of those 22 changes; and 4. Considering the availability of the data, the most appropriate sources of the data and the cost of providing the data; and be it further Sec. 5. Funding and staffing. Resolved: That the department shall provide staffing assistance to the working group through contracted professional services and 27 shall seek outside nonstate funding to support staffing services and administrative costs 28 for the working group. If adequate funding is not obtained, the working group may not 29 convene or incur any expenses; and be it further Sec. 6. Report. Resolved: That, by January 31, 2012, the department shall report 31 the recommendations based on the findings and conclusions, determined by vote, of the 32 working group, along with any recommended implementing legislation, to the Joint Standing Committee on Health and Human Services.' 33 34 **SUMMARY** 35 This amendment replaces the bill with a resolve that creates a working group to review and make recommendations on the availability of and access to health care data 36 37 and to examine the all-payor claims database systems. The working group consists of 17 38 members, all invited to participate by the Commissioner of Health and Human Services.
