#### **Fiscal Detail and Notes**

This amendment transfers \$6,960 in fiscal year 2011-12 from the Office of Program Evaluation and Government Accountability to the Legislature to offset the estimated costs of the Commission to Study Allocations of the Fund for a Healthy Maine.
