Fiscal Detail and Notes

This amendment reduces the General Fund cost of the bill by \$101,500 in fiscal year 2011-12 and \$92,000 in fiscal year 2012-13. The bill, as amended by this amendment, includes a General Fund appropriation of \$70,000 in fiscal year 2011-12 and \$16,000 in fiscal year 2012-13 for one-time and on-going information technology costs.
