In setting a reasonable fee for each category of abstracts and copies, the commissioners shall consider factors relating to the cost of producing and making copies available, which may include, but are not limited to: the cost of depleted supplies; records storage media costs; actual mailing and alternative

## SUMMARY

This amendment provides that the fees that may be collected by a register of deeds are \$5 per page for making paper abstracts and copies of plans, \$1 per page for other paper abstracts and copies,  $50\phi$  per page for digital abstracts and copies and  $5\phi$  per page for copies of 1,000 or more digital abstracts and copies of consecutive records. The amendment also repeals the fee changes July 31, 2012 and restores current fee provisions on that date.
