9	COMMITTEE AMENDMENT "A" to H.P. 1120, L.D. 1526, Bill, "An Act
10	Regarding Corporate and Other Entity Campaign Advertising Disclosure and
11	Accountability"
12	Amend the bill by striking out everything after the enacting clause and before the
13	summary and inserting the following:
14	'Sec. 1. 21-A MRSA §1019-B, sub-§5 is enacted to read:
15	5. Reporting required by certain groups. An entity other than an individual,
16	political action committee, party committee, political committee or ballot question
17 18	committee, including, but not limited to, a corporation, firm, partnership, trade union, professional union, trade association or professional association, shall file a report with
19	the commission that meets the requirements of this subsection and subsection 4 when the
20	entity makes expenditures aggregating in excess of \$2,000 for a communication as
21	described in section 1014, subsection 2. The report must include a certification by an
22	officer or agent of the entity stating that the expenditure for the communication was
23 24	authorized within the 12-month period before the expenditure for the communication by, as applicable, an officer, a board of directors, an executive council, shareholders or an
25	organizational leadership body of the entity.'
	<u>Output</u>
26	SUMMARY
27	This amendment is the majority report and establishes reporting requirements for an
28	entity other than an individual, political action committee, party committee, political
29	committee or ballot question committee for an independent expenditure greater than
30 31	\$2,000 for a communication not authorized by a candidate. The report requires
51	certification by the governing body of that entity that the expenditure was approved.
