## **SUMMARY**

This amendment does the following.

9 10 1. It deletes provisions relating to enrollment preference for children of a public charter school's founder, governing board member or full-time employee.

11 12 2. It provides that public charter schools authorized by the State Charter School Commission must be approved by local school boards.

13

3. It provides that an authorizer may not approve more than 3 public charter schools.

14 15 4. It provides that renewal terms may not exceed 10 years or 5 years if the school is not performing adequately.

5. It requires performance reports to be issued in the 3rd year of operation rather than the 4th year

the 4th year.

18 19 6. It requires, rather than authorizes, the revocation of a charter under conditions specified in the committee amendment.

7. It limits a charter contract to 3 schools.

21 22 8. It deletes a requirement that teachers employed by a public charter school may not be required to be part of a collective bargaining agreement between a school administrative unit and its employees.

9. It limits a single authorizing entity to 3 charter contracts.
