SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 1144, L.D. 1558, "Resolve, To Study Allocations of the Fund for a Healthy Maine"

Amend the amendment in section 9 in the last line (page 1, line 35 in amendment) by striking out the following: "Services." and inserting the following: 'Services; and be it further'

Amend the amendment by inserting after section 9 the following:

Sec. 10. Transfer of funds; Office of Program Evaluation and Government Accountability, General Fund. Resolved: That, on the effective date of this resolve, the State Controller shall transfer \$6,960 from the Office of Program Evaluation and Government Accountability, General Fund account to the Miscellaneous Studies Legislative, General Fund account in the Legislature to fund the costs of the study.'

This amendment transfers \$6,960 from the Office of Program Evaluation and Government Accountability to fund the costs of the study to be done by the Commission To Study Allocations of the Fund for a Healthy Maine.
