SENATE AMENDMENT "A" to S.P. 500, L.D. 1567

Amend the amendment by striking out all of the 2nd indented paragraph after the title (page 1, lines 13 to 15 in amendment) and inserting the following:

'Amend the resolve in section 1 in subsection 1 by striking out all of the last paragraph (page 1, lines 13 to 18 in L.D.) and inserting the following:

'The office may only acquire real estate associated with the disposal facility by donation and may establish the terms and conditions of acquisition by donation and execute and deliver, in the name of and on behalf of the State, all contracts the office determines are necessary or appropriate to effect the acquisition and operation of the disposal facility. The office shall undertake all actions the office determines necessary or appropriate to fully perform all obligations established under the contracts.'

Amend the amendment by adding before the summary the following:

'Amend the resolve by adding after section 2 the following:

13 'Emergency clause. In view of the emergency cited in the preamble, this
14 legislation takes effect when approved.''

SUMMARY

This amendment provides that the Executive Department, State Planning Office may only acquire real estate associated with the solid waste disposal facility in East Millinocket by donation. The amendment also adds an emergency preamble and emergency clause.
