1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §8201**, as amended by PL 1995, c. 485, §1, is further
3 amended to read:

4 **§8201. School established**

5 The Maine School of Science and Mathematics is established as a public, ~~chartered~~
6 magnet school pursuant to this chapter for the purpose of providing certain high-
7 achieving high school students with a challenging educational experience. The school is
8 a body politic and corporate and is an instrumentality and agency of the State. The
9 exercise by the school of the powers conferred by this chapter is the performance of an
10 essential public function by and on behalf of the State.

11 **Sec. 2. 20-A MRSA §8203, sub-§2**, as enacted by PL 1993, c. 706, Pt. A, §4, is
12 amended to read:

13 **2. Magnet school.** "~~Chartered~~ Magnet school" means that the school may establish
14 rules and regulations that delete, modify or add to current rules and regulations of the
15 department.

16 **Sec. 3. 20-A MRSA §8204, sub-§1, ¶J**, as enacted by PL 1993, c. 706, Pt. A, §4,
17 is amended to read:

18 J. The ~~superintendent~~ executive director of the school, who serves as the clerk of the
19 board of trustees and is a nonvoting member.

20 **SUMMARY**

21 This bill updates the laws concerning the Maine School of Science and Mathematics
22 to change the designation of the school from a chartered school to a magnet school and
23 changes the title of "superintendent" of the school to "executive director" to avoid
24 confusion with other statutory terms.
