1 Sec. 1. Role of 3rd-party laboratories conducting testing. Resolved: That 2 the Department of Marine Resources shall examine the role of 3rd-party laboratories in 3 conducting testing for the department. The Commissioner of Marine Resources or the 4 commissioner's designee shall analyze the findings to determine how the department may 5 save money, create jobs, promote competition, use less testing and share data to save 6 research time; and be it further

7 Sec. 2. Report. Resolved: That the Department of Marine Resources shall report 8 its findings under section 1 to the joint standing committee of the Legislature having 9 jurisdiction over marine resources matters by January 15, 2013 together with any 10 recommendations regarding the role of 3rd-party laboratories in conducting testing for the 11 department. The committee may submit a bill based on the findings and 12 recommendations of the report submitted by the Department of Marine Resources to the 13 First Regular Session of the 126th Legislature.

SUMMARY

15 This resolve directs the Department of Marine Resources to examine the role of 16 3rd-party laboratories in conducting testing for the department. The resolve also requires 17 the department to report its findings to the joint standing committee of the Legislature 18 having jurisdiction over marine resources matters by January 15, 2013 and allows the 19 committee to submit a bill to the First Regular Session of the 126th Legislature.
