16 17 18 19	Amend the bill in Part A in section 3 in §5207 in subsection 4 in the last 3 lines (page 2, lines 33 to 35 in L.D.) by striking out the following: "Before accepting applications, an open enrollment school that is a private school shall publicize the school's cost for tuition and fees, and the amount of tuition that will be paid by the sending school unit."

	19	This amendment is the minority report. This amendment limits the open enrollment
	20	program to public schools by removing references to private schools approved for tuition
	21	purposes from the definition of "eligible school" and from sections of the bill relating to
	22	student eligibility and funding. It also provides state subsidy to a minimum receiver
	23	school unit which is a school administrative unit that would otherwise not receive

This legislation will not increase the total cost of Essential Programs and Services or the State's share of that cost. However, this bill will result in a redistribution of state subsidy to local school administrative units (SAU's) with subsidy increasing to those SAU's that receive open enrollment students and subsidy decreasing to those SAU's that send open enrollment students to open enrollment schools.
