For the purposes of this section, "instrumental activities of daily living" means essential, nonmedical tasks that enable the consumer to live independently in the community, including light housework, preparing meals, taking medications, shopping for groceries or clothes, using the telephone, managing money and other similar activities. The department shall evaluate:

Sec. 2. Inquiry regarding Medicaid waiver or state plan amendment. Resolved: That by January 1, 2014 the Department of Health and Human Services shall submit an inquiry to the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services regarding the feasibility of obtaining a Medicaid waiver or a state plan amendment to enable the State to provide coverage for instrumental activities of daily living, as defined in section 1, under the MaineCare program. The inquiry must provide to the Centers for Medicare and Medicaid Services information regarding the need for services for instrumental activities of daily living among persons currently receiving services under the state-funded homemaker services program and persons currently on the waiting list for those services and the potential for savings from providing services under the Medicaid program; and be it further

16 Sec. 3. Application for waiver or state plan amendment. Resolved: That if 17 based on the review of costs and potential savings in section 1 and if, in response to the 18 inquiry made under section 2, the United States Department of Health and Human 19 Services, Centers for Medicare and Medicaid Services indicates that it is feasible for the 20 State to obtain a Medicaid waiver or state plan amendment to enable the State to provide coverage for instrumental activities of daily living, as defined in section 1, the 21 22 Department of Health and Human Services shall apply by July 1, 2014 for the necessary 23 waiver or submit the state plan amendment using the information gathered pursuant to the review of the need for services, the analysis of costs and potential savings and the 24 25 projection of needs and costs undertaken pursuant to section 1.'

SUMMARY

27 This amendment replaces the bill with a resolve and directs the Department of Health 28 and Human Services to begin by December 1, 2013 reviewing and analyzing the need for 29 services for instrumental activities of daily living among Maine's populations who are 30 elderly or who have disabilities, the costs of providing services, the potential for savings 31 and projections of need. This amendment directs the Department of Health and Human 32 Services based on its review of costs and potential savings to submit by January 1, 2014 33 an inquiry to the United States Department of Health and Human Services, Centers for 34 Medicare and Medicaid Services regarding the feasibility of obtaining a Medicaid waiver 35 or a state plan amendment to enable the State to provide coverage for instrumental 36 activities of daily living under the MaineCare program. If in response to the inquiry the 37 Centers for Medicare and Medicaid Services indicates that it is feasible to obtain a

Fiscal Detail and Notes

The amendment eliminates the bill's ongoing annual appropriation of \$1.5 million for the independent support services (homemaker services) program in the Department of Health and Human Services. Additional costs resulting from the amendment for the Department of Health and Human Services for the review, analysis and preparation of a federal waiver or State plan amendment are assumed to be minor and can be absorbed within existing budgeted resources.
