Amend the bill by striking out everything after the title and before the summary and inserting the following:

**'Sec. 1. Department of Health and Human Services directed to increase reimbursement rates for adult day services. Resolved:** That the Department of Health and Human Services is directed to increase reimbursement rates for adult day services programs in Chapter 101: MaineCare Benefits Manual, Chapter II, Sections 19 and 26 and Chapter 5: Office of Elder Services Policy Manual, Sections 61 and 63 to \$12 an hour beginning October 1, 2013; and be it further

**Sec. 2. Appropriations and allocations. Resolved:** That the following appropriations and allocations are made.
