5	includes 2 Legislators, 5 representatives of state agencies, 4 persons living with
6	HIV/AIDS, 2 representatives of populations most affected by HIV/AIDS in the State, 2
7	providers of HIV-related services, 2 representatives of the public health community and 2
8	additional members chosen by the membership.
