12 13	Amend the bill in section 2 by striking out all of subsection 5 (page 3, lines 30 to 38 in L.D.) and inserting the following:

A junior hunter or a person 65 years of age or older resident may take an antlerless deer if a person another resident who holds a valid antlerless deer permit transfers the permit to the junior hunter or person 65 years of age or older that resident by identifying the name, age and address of the transferee on the permit as well as any other information reasonably requested by the commissioner and then returns the permit to the department prior to the start of the firearm season on deer. A nonresident may take an antlerless deer if another nonresident who holds a valid anterless deer permit transfers the permit to that nonresident by identifying the name and address of the transferee on the permit to that nonresident by identifying the name and address of the transferee on the permit as well as any other information reasonably requested by the commissioner and then returns the permit to the department prior to the start of the firearm season on deer. A nonresident may take an antlerless deer if another nonresident by identifying the name and address of the transferee on the permit as well as any other information reasonably requested by the commissioner and then returns the permit to the department prior to the start of the firearm season on deer. The commissioner shall record the a transfer under this subsection and return the permit to the junior hunter or person 65 years of age or older transferee. A valid permit must be in the possession of the transferee in order for the transferee to take an antlerless deer.'

29 30 31 32 33 34 35 36	'Sec. 4. Updating of the Maine Online Sportsman's Electronic System. The Department of Inland Fisheries and Wildlife shall survey users of its online system for purchasing licenses and registrations, known as the Maine Online Sportsman's Electronic System, and, based on the information obtained from those users, develop a plan for updating that system. The plan must focus on updating the system's user interface and provide options for online renewal of trapping licenses and guide licenses. The department shall submit its plan, together with a proposed budget for implementing the plan, to the Joint Standing Committee on Inland Fisheries and Wildlife by December

1. Removes the sections of the bill that extend the lifetime license system and establish a task force to reduce the number of licenses and permits;

28 2. Modifies the provisions of the bill allowing any person, regardless of age, to 29 transfer an antlerless deer permit to another person to clarify that a resident may transfer a 30 permit only to another resident and a nonresident may transfer a permit only to another 31 nonresident;

32 3. Modifies the provisions of the bill that require the Department of Inland Fisheries 33 and Wildlife to develop a plan for updating its online system for persons to purchase 34 licenses and registrations to require that the plan be based on a user survey, to require that 35 it focus on the user interface and provide options for online renewal of trapping and guide 36 licenses and to extend the date for completion of the plan to December 1, 2013;

Fiscal Detail and Notes

The bill includes a one-time Other Special Revenue Funds allocation to the Department of Inland Fisheries and Wildlife of \$10,000 in fiscal year 2013-14 for an actuarial study to review expanding the availability of lifetime hunting and fishing licenses. Funding exists within this account to cover the allocation. Additional costs to the department associated with surveying users of the licensing system and developing a plan to update the system can be absorbed within existing budgeted resources.
