COMMITTEE AMENDMENT "A" to H.P. 192, L.D. 231, Bill, "An Act To Support the Permanent Commission on the Status of Women"

Amend the bill in section 2 in §7030-D in the indented paragraph in the last line (page 1, line 21 in L.D.) by inserting after the following: "chapter," the following: 'Funds received under this section must be deposited in a nonlapsing Other Special Revenue Funds account within the Department of the Secretary of State to support the work of the commission.'

Amend the bill by inserting after section 2 the following:

'Sec. 3. Appropriations and allocations. The following appropriations and allocations are made.

Initiative: Creates the Permanent Commission on the Status of Women account with a base allocation.
