16 17 18 19 20 21	Amend the amendment in section 1 in subsection 1 in paragraph B in the 2nd and 3rd lines (page 1, lines 21 and 22 in amendment) by striking out the following: ", slungshot, knuckles, bowie knife, dirk, stiletto or other dangerous or deadly weapon usually employed in the attack on or defense of a person" and inserting the following: ', slungshot, knuckles, bowie knife, dirk, stiletto or other dangerous or deadly weapon usually employed in the attack on or defense of a person' and inserting the following: ', slungshot, knuckles, bowie knife, dirk, stiletto or other dangerous or deadly weapon usually employed in the attack on or defense of a person'

29	SUMMARY
30 31	Current law prohibits a person from displaying in a threatening manner a dangerous or deadly weapon and from concealing a dangerous or deadly weapon.
32 33 34	This amendment applies those prohibitions only to a firearm and removes the application of the statute to other dangerous and deadly weapons.
