COMMITTEE AMENDMENT "A" to H.P. 377, L.D. 558, "Resolve, To Erect a State Monument to Franco-Americans"

Amend the resolve in section 1 in the first line (page 1, line 1 in L.D.) by inserting after the following: "That" the following: ', upon availability of sufficient funding,'

Amend the resolve in section 2 in the 2nd line (page 1, line 6 in L.D.) by striking out the following: "state and"

Amend the resolve in section 2 in the 3rd line (page 1, line 7 in L.D.) by striking out the following: "resolve." and inserting the following: 'resolve; and be it further'

Amend the resolve by inserting after section 2 the following:

Sec. 3. Appropriations and allocations. Resolved: That the following appropriations and allocations are made.
