The working group shall request that school boards and superintendents provide copies of school administrative units' agreements for energy conservation improvements and financial information related to such agreements or other energy savings programs. The working group shall also consider other options available to school boards that can reduce the costs and increase the benefits of energy savings programs and energy conservation improvements; and be it further

The joint standing committee is authorized to submit a bil to the Second Regular Session of the 126th Legislature.
