HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to H.P. 534,
L.D. 783, Bill, "An Act To Change the Voting Requirements for the Withdrawal of a
Municipality from a Regional School Unit"

Amend the amendment by inserting after the title and before the first indented
paragraph the following:

'Amend the bill by striking out all of the emergency preamble (page 1, lines 1 to 11 in
L.D.).'

Amend the amendment by striking out section 8 and inserting the following:

Sec. 8. Administrative costs. Notwithstanding any provision of law to the
contrary, if a municipality that is a member of a regional school unit withdraws from that
regional school unit pursuant to the Maine Revised Statutes, Title 20-A, section 1466,
subsection 9, any increase in administrative costs incurred by that municipality as a result
of that withdrawal must be borne by that municipality.

Sec. 9. Appropriations and allocations. The following appropriations and
allocations are made.

School Finance and Operations Z078

Initiative: Provides funds for one Education Specialist II position and one Education
Specialist III position and related All Other costs through June 30, 2016 to support the
anticipated increase in workload associated with the withdrawal process of individual
municipalities from regional school units.

Fiscal Detail and Notes

This amendment reduces the General Fund appropriations in the bill by \$43,522 in fiscal year 2013-14 and \$643,500 in fiscal year 2014-15 as a result of removing the emergency provision and clarifying that any administrative costs incurred by a municipality as a result of withdrawing from a regional school unit pursuant to this legislation must be borne by that municipality.

As amended, this bill includes General Fund appropriations of \$134,881 in fiscal year 2013-14 and \$182,926 in fiscal year 2014-15 to the School Finance and Operations Program within the Department of Education for one Education Specialist II position and one Education Specialist III position and related all other costs to support the anticipated increase in workload associated with the process of municipalities withdrawing from regional school units. This fiscal note assumes that the positions begin in October of 2013 and that the increased workload will subside in fiscal year 2016-17 and these positions will end.
