COMMITTEE AMENDMENT "A" to S.P. 292, L.D. 867, Bill, "An Act To Streamline, Amend and Clarify Certain Professional and Occupational Licensing Statutes"

Amend the bill in Part D by inserting after section 1 the following:

'Sec. D-2. Appropriations and allocations. The following appropriations and allocations are made.

**PROFESSIONAL AND FINANCIAL REGULATION, DEPARTMENT OF
Licensing and Enforcement 0352**

Initiative: Reduces Personal Services and All Other allocations due to the decrease in the number of members of the State Board of Funeral Services from 8 to 7.

Amend the bill in Part G by inserting after section 1 the following:

'Sec. G-2. 32 MRSA §13857, sub-§2, ¶D, as enacted by PL 2003, c. 542, §1 and amended by PL 2011, c. 286, Pt. B, §5, is repealed.'

Amend the bill by adding after Part K the following:

'PART L

Sec. L-1. 32 MRSA §3656, last ¶, as enacted by PL 2007, c. 402, Pt. P, §14, is repealed.'

COMMITTEE AMENDMENT

R. S.

1 Amend the bill by relettering or renumbering any nonconsecutive Part letter or
2 section number to read consecutively.

3 **SUMMARY**

4 This amendment repeals a provision relating to service of process on nonresidents in
5 the laws governing the Board of Counseling Professionals Licensure and repeals a cross-
6 reference to informal conferences in the statutes of the Board of Licensure of Podiatric
7 Medicine, in order to conform those statutes to the repeal in Public Law 2011, chapter
8 286 of all other references to informal conferences in the laws governing the Office of
9 Professional and Occupational Regulation.

10 The amendment adds an appropriations and allocations section to the bill.
