Resolved: That the office of substance abuse and mental health services within the Department of Health and Human Services shall provide a report of data from 2009 to 2013 from methadone clinics in this State. The report must be provided to the Joint Standing Committee on Health and Human Services no later than January 1, 2014. The report must include, but is not limited to, the following data:
23	1. The number of clients at the clinics;
24	2. The number of clients receiving take-home doses of methadone;

#### SUMMARY

This amendment, which is the minority report of the committee, requires the office of substance abuse and mental health services within the Department of Health and Human Services to prepare a report using data from 2009 to 2013 from methadone clinics in this State. The report must be submitted to the Joint Standing Committee on Health and Human Services no later than January 1, 2014. The report must include, but is not limited to, data on the number of clients at the clinics, the number of clients receiving athome doses of methadone, the average doses and range of doses of methadone received by clients both at the clinic and receiving athomes doses, the incidence of tapering of the dosage, including any changes in tapering resulting from the enactment of a lifetime limit of 2 years, the frequency of drug use and the number of arrests in the last 30 days of clients at the clinics, the number of clients discharged and the reasons for the discharges and the number of clients.
