An Act To Require Legislative Approval for the Issuance of Bonds by the Maine Turnpike Authority

1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 23 MRSA §1961, sub-§2, as amended by PL 2011, c. 302, §2, is further
 amended to read:

4 2. Cooperation with the Department of Transportation. The Subject to approval by the Legislature in accordance with subsection 6, the authority may issue bonds or 5 other obligations to pay for department projects. These amounts are considered necessary 6 7 for use by the department for construction, reconstruction, operation and maintenance of all roads on the state highway system, which serve and benefit users of the turnpike by 8 9 providing direct and indirect access to and from the turnpike as part of the integrated 10 highway system. Due to the utilization of the state highway system by users of the turnpike, the turnpike and its users have received and will continue to receive a benefit 11 from, or have caused and will continue to cause, or both, the State acting by and through 12 the department to incur costs for the construction, operation and maintenance of the state 13 highway system, which provides direct and indirect access to and from the turnpike to 14 areas in the State for which the State may properly be and should be compensated from 15 the tolls to be collected. The authority must be maintained to carry out the purposes of 16 17 this chapter in cooperation with the department.

20 6. Appropriation. On or before January 31st of each year, the authority shall 21 present to each regular session of the Legislature for its approval the authority's revenue fund budget and the authority's proposed issuance of bonds for the calendar year that 22 23 begins after the adjournment of that regular session and shall present to each regular session of the Legislature for informational purposes a statement of the revenues 24 necessary during the next calendar year to fund capital expenditures and reserves and to 25 26 meet the requirements of any resolution authorizing bonds of the authority, including debt service and the maintenance of reserves for debt service and reserve maintenance. The 27 28 authority shall present a detailed budget of expenditures from the authority's reserve 29 maintenance fund for the next calendar year and shall include cross-references to show 30 the total of similar expense categories that are paid from both the revenue and reserve 31 maintenance funds. The authority may only pay revenue fund operating expenses in accordance with allocations approved by the Legislature or as necessary to satisfy the 32 requirements of any resolution authorizing bonds of the authority. If alterations to the 33 authority's revenue fund budget are needed, they must be reported by financial order to 34 35 the joint standing committee of the Legislature having jurisdiction over transportation 36 matters.
