11	Amend the bill by striking out the title and substituting the following:
12	'An Act To Impose a Duty To Warn and Protect on Health Professionals'
13 14	Amend the bill by inserting after the enacting clause and before section 1 the following:
15	'Sec. 1. 32 MRSA §2600-C is enacted to read:
16	§2600-C. Duty to warn and protect
17	1. Duty. An osteopathic physician licensed under this chapter has a duty to warn of
18	or to take reasonable precautions to provide protection from a patient's violent behavior if
19 20	the osteopathic physician has a reasonable belief based on communications with the
21	patient that the patient is likely to engage in physical violence that poses a serious risk of harm to self or others or that constitutes a serious threat of substantial damage to real
22	property. The duty imposed under this subsection may not be interpreted to require the
23	osteopathic physician to take any action that in the reasonable professional judgment of
24	the osteopathic physician would endanger the osteopathic physician or increase the threat
25	of danger to a potential victim.
26	2. Discharge of duty. An osteopathic physician subject to a duty to warn or provide
27	protection under subsection 1 may discharge that duty if the osteopathic physician makes
28	reasonable efforts to communicate the threat to a potential victim, notifies a law
29	enforcement agency or seeks involuntary hospitalization of the patient under Title 34-B,
30	chapter 3, subchapter 4, article 3.
31	3. Immunity. The decision of an osteopathic physician to take or not to take an
32	action authorized under this section may not be the basis for any civil or criminal liability
33	of the osteopathic physician.'
34 35	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
