11 12	Amend the bill by striking out all of section 1 (page 1, lines 2 to 13 in L.D.) and inserting the following:
13 14	'Sec. 1. 1 MRSA §408-A, sub-§3, as enacted by PL 2011, c. 662, §5, is amended to read:
15 16 17 18 19 20 21 22 23	3. Acknowledgment; clarification; time estimate; cost estimate. The agency or official having custody or control of a public record shall acknowledge receipt of a request made according to this section within a reasonable period of time, 5 working days of receiving the request and may request clarification concerning which public record or public records are being requested. The Within a reasonable time of receiving the request, the agency or official shall provide a good faith, nonbinding estimate of the time within which the agency or official will comply with the request, as well as a cost estimate as provided in subsection 9. The agency or official shall make a good faith effort to fully respond to the request within the estimated time.'
24 25	Amend the bill in section 2 in subsection 4 in the 4th line (page 1, line 19 in L.D.) by striking out the following: "working <u>calendar</u> " and inserting the following: 'working'
26	Amend the bill by striking out all of section 3 (page 1, lines 22 to 29 in L.D.)
27	Amend the bill by striking out all of section 5 (page 2, lines 1 to 10 in L.D.)
28 29	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

31 32 33	This amendment requires an agency or official to acknowledge a request to inspect or copy public records within 5 working days of receiving the request. Within a reasonable time of receiving the request, the agency or official must give a good faith, nonbinding
