Amend the bill by inserting after the title the following:

'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the feeding of bear, moose and wild turkey is creating a public safety hazard and having a detrimental effect on the bear, moose and wild turkey populations; and

Whereas, the open season on hunting bear begins on August 26th, bait to hunt bear may be placed beginning July 27th and hunters may train dogs on bear beginning July 1st; and

Whereas, Maine guides rely on bear hunting for their individual livelihoods, and communities in rural regions of the State depend on bear hunting for economic activity to help sustain their local economies; and

Whereas, migratory game bird hunting begins in October; and

Whereas, the importation and possession of wildlife requires immediate study; and

Whereas, the 90-day period will not end before the first events begin; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,'

Amend the bill in section 1 in subsection 39 by striking out all of paragraph B (page 1, lines 6 and 7 in L.D.) and inserting the following:

'B. Columbidae, or pigeons, including doves and wild pigeons, but not including rock doves, also known as rock pigeons;'

5	SUMMARY
6	This amendment adds an emergency preamble and clause to the bill. It clarifies that
7	rock doves, also known as "rock pigeons" and which the bill adds to the list of wild birds
8	that may be hunted, are not included in the definition of "migratory game bird." It repeals
9	the Maine Revised Statutes, Title 12, section 12051, subsection 2, which requires a
10	permit to take rock doves from the wild for the purpose of training dogs since a rock dove
11	is not a migratory game bird. It makes further changes to the laws regarding the
12	placement of bear bait to prohibit hunting, trapping, molesting or harassing wildlife,
13	using chemicals or releasing dogs in the vicinity of existing bait sites. It also requires
14	nonresidents hunting bear with the use of a dog or dogs to be within visual and voice
15	contact of a resident Maine guide. Finally, it makes the penalty for violation of hunting
16	bear over another person's bait without permission a mandatory hunting license
17	revocation.
