For the purposes of this section, a written practice agreement is a signed document that, in conformity with the legal scope of practice provided in section 1094-HH, outlines the functions that the dental hygiene therapist is authorized to perform. A dental hygiene therapist may practice only under the standing order of a supervising dentist, may provide only care that follows written protocols and may provide only services that the dental hygiene therapist is authorized to pervising dentist.'

 rules, the board shall consult with:

 dental hygienist's patients are eligible for the MaineCare program;
 - 5. A person whose area of expertise is in public health; and
- 30 6. A member of an organization that advocates for low-income persons.

Page 3 - 126LR1022(16)-1

SENATE AMENDMENT "A " to COMMITTEE AMENDMENT "C" to H.P. 870, L.D. 1230

1. It removes the requirement that a dental hygiene therapy education program meet the requirements established by the Department of Professional and Financial Regulation, Board of Dental Examiners and removes the ability of the board to approve a dental hygiene therapy education program that has not been accredited by the American Dental Association Commission on Dental Accreditation; 1

2. It limits the number of dental hygiene therapists with whom a supervising dentist may enter into a written practice agreement at one time to 10;

3. It leaves the type of rules adopted by the board as major substantive, as was specified in Committee Amendment "C," but only until September 1, 2016. Beginning September 1, 2016, the rules adopted by the board are routine technical rules; and

4. It changes an occurrence of general supervision to direct supervision in
 Committee Amendment "C" to correct an inadvertent omission.
