The commissioner shall specify construction standards designed to minimize impact on the deer in these areas.

Standards adopted by the commissioner under this subsection must ensure that trails are designed, constructed and maintained to avoid erosion and sedimentation, limit clearing of vegetation, limit structural development, protect deer from undue disturbance during critical winter time and otherwise promote and protect deer wintering habitat.
27 28 29	B. The Maine Land Use Planning Commission shall incorporate the standards adopted pursuant to this subsection in land use standards prescribed under section 685-A, subsection 3.
30 31 32	C. A person who constructs a trail in a deer wintering area in violation of rules adopted under this subsection commits a civil violation for which a fine of not more than \$10,000 may be adjudged.

34 35 36 37	This bill directs the Commissioner of Inland Fisheries and Wildlife, in consultation with the Maine Land Use Planning Commission and the Commissioner of Agriculture, Conservation and Forestry, to adopt rules that establish standards for the construction of trails in deer wintering areas.
