Amend the bill in section 4 in the first line (page 1, line 16 in L.D.) by striking out the following: "2014" and inserting the following: '2015'

Amend the bill in section 4 in the 3rd line (page 1, line 18 in L.D.) by striking out the following: "2014" and inserting the following: '2015'

Amend the bill by adding after section 4 the following:

**Sec. 5. Appropriations and allocations.** The following appropriations and allocations are made.

**AGRICULTURE, CONSERVATION AND FORESTRY, DEPARTMENT OF  
Maine Land Use Planning Commission Z236**

Initiative: Provides one-time funding for rulemaking in fiscal year 2014-15.
