# 1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 5 MRSA §1825-B, sub-§1, as amended by PL 1991, c. 780, Pt. Y, §70, is
further amended to read:

4 1. Purchases by competitive bidding; restrictions. The Director of the Bureau of 5 General Services shall purchase collectively all goods and services for the State or any department or agency of the State in a manner that best secures the greatest possible 6 7 economy consistent with the required grade or quality of the goods or services. Except as 8 otherwise provided by law, the Director of the Bureau of General Services shall make 9 purchases of goods or services needed by the State or any department or agency of the 10 State through competitive bidding. Beginning January 1, 2014, the Director of the Bureau of General Services shall exclude any business entity or individual from doing 11 business with the State if that business entity or individual does business with any 12 company, or any subsidiary, affiliate or parent of any company, that does business with a 13 14 country designated as a state sponsor of terrorism under the federal Export Administration Act of 1979, 50 United States Code, Section 2405(j) (2000); the federal 15 Arms Export Control Act, 22 United States Code, Section 2780(d) (2000); or the federal 16 17 Foreign Assistance Act of 1961, 22 United States Code, Section 2371(a) (2000).

29 Beginning January 1, 2014, the University of Maine System, the Maine Community College System and the Maine Maritime Academy shall exclude any business entity or 30 individual from doing business with the University of Maine System, the Maine 31 32 Community College System and the Maine Maritime Academy if that business entity or 33 individual does business with any company, or any subsidiary, affiliate or parent of any 34 company, that does business with a country designated as a state sponsor of terrorism 35 under the federal Export Administration Act of 1979, 50 United States Code, Section 36 2405(j) (2000); the federal Arms Export Control Act, 22 United States Code, Section 37 2780(d) (2000); or the federal Foreign Assistance Act of 1961, 22 United States Code, 38 Section 2371(a) (2000).

39 Sec. 4. 30-A MRSA §109 is enacted to read:

#### 1 §109. Policy against doing business with certain entities

The county commissioners shall adopt a policy by January 1, 2014 to exclude any 2 3 business entity or individual from doing business with the county if that business entity or individual does business with any company, or any subsidiary, affiliate or parent of any 4 5 company, that does business with a country designated as a state sponsor of terrorism under the federal Export Administration Act of 1979, 50 United States Code, Section 6 2405(j) (2000); the federal Arms Export Control Act, 22 United States Code, Section 7 8 2780(d) (2000); or the federal Foreign Assistance Act of 1961, 22 United States Code, Section 2371(a) (2000). 9

#### 11 §2007. Prohibition on doing business with certain entities

12 Beginning January 1, 2014, a municipal legislative body shall exclude any business entity or individual from doing business with the municipality if that business entity or 13 individual does business with any company, or any subsidiary, affiliate or parent of any 14 company, that does business with a country designated as a state sponsor of terrorism 15 under the federal Export Administration Act of 1979, 50 United States Code, Section 16 17 2405(j) (2000); the federal Arms Export Control Act, 22 United States Code, Section 2780(d) (2000); or the federal Foreign Assistance Act of 1961, 22 United States Code, 18 Section 2371(a) (2000). 19

# SUMMARY

21 This bill requires that, beginning January 1, 2014, the State, the University of Maine System, the Maine Community College System, the Maine Maritime Academy and 22 23 municipalities exclude any business entity or individual from doing business with the 24 State, the University of Maine System, the Maine Community College System, the Maine 25 Maritime Academy or a municipality if that business entity or individual does business 26 with any company, or any subsidiary, affiliate or parent of any company, that does business with a country designated by federal law as a state sponsor of terrorism. It also 27 28 requires that counties and school boards adopt policies by January 1, 2014 that require 29 counties and school boards to exclude any business entity or individual from doing business with a county or school board if that business entity or individual does business 30 with any company, or any subsidiary, affiliate or parent of any company, that does 31 32 business with a country designated as a state sponsor of terrorism.
