**An Act To Address the Burden Placed on Students as a Result of
Requirements To Take Remedial Courses**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §10012, sub-§1, ¶B,** as enacted by PL 2011, c. 615, §1, is
3 amended to read:

4 B. The name of each secondary school in the State from which a traditional student
5 enrolled in a remedial course received a high school diploma ~~and~~, the number of
6 those students from each of those schools and the costs to those students resulting
7 from taking the remedial courses; and

8 **Sec. 2. 20-A MRSA §10012, sub-§4,** as enacted by PL 2011, c. 615, §1, is
9 repealed.

10 **Sec. 3. 20-A MRSA §15689, sub-§6-A** is enacted to read:

11 **6-A. Adjustment for costs of remedial courses.** The commissioner shall reduce the
12 state share of the total allocation to a school administrative unit by an amount equal to the
13 cost of remedial courses taken at the University of Maine System, the Maine Community
14 College System and the Maine Maritime Academy, referred to in this subsection as
15 "public institutions of higher education," by students who graduated from that school
16 administrative unit, as identified pursuant to section 10012, subsection 1, paragraph B.
17 The reduction must occur in a first school year that a student took a remedial course,
18 beginning after the issuance of the report pursuant to section 10012. The commissioner
19 shall forward the amount of state share by which the total allocation to a school
20 administrative unit is reduced to the treasurer of the appropriate public institution of
21 higher education. Each public institution of higher education that receives funds under
22 this subsection shall use the funds to reduce or eliminate the cost to students of taking
23 remedial courses and shall describe how it used the funds to achieve that reduction or
24 elimination in the report submitted under section 10012.

25 **SUMMARY**

26 Under current law, the University of Maine System, the Maine Community College
27 System and the Maine Maritime Academy are required to report on the number of
28 remedial courses taken by students from each school administrative unit in the subjects of
29 English language arts and mathematics. This bill requires those institutions to report the
30 cost to the students of those remedial courses, by school administrative unit, and requires
31 the Commissioner of Education to reduce state subsidy to the school administrative units
32 and to pay those funds to the higher education institution. Those higher education
33 institutions are required to use the funds to reduce or eliminate the cost of remedial
34 courses to their students and to report to the Commissioner of Education and the
35 Legislature how those funds were used to achieve the reduction or elimination of costs.
