7 E. Commissioner District Number 5, in the County of York, consists of the minor  
8 civil divisions of Eliot, Kittery, Ogunquit, Wells and York. The term of office of the  
9 commissioner from this district expires in 2016 and every 4 years thereafter.'

10 **SUMMARY**

11 This amendment corrects erroneous county designations for certain House Districts  
12 and makes other technical changes to reflect the proper names of areas in the unorganized  
13 territory. This amendment also adjusts the expiration of terms for certain county  
14 commissioners to ensure that the terms remain staggered.
