An Act To Fund the Agreement with Certain Judicial Department **Employees**

(AFTER DEADLINE)

(EMERGENCY)

Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.

- 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and
- 3 **Whereas,** the Judicial Department has reached a collective bargaining agreement 4 with the 4 bargaining units representing Judicial Department employees; and
- 5 **Whereas,** this legislation authorizes funding of the agreement effective at the 6 beginning of the pay week commencing closest to September 1, 2013; and

Whereas, in the judgment of the Legislature, these facts create an emergency within
the meaning of the Constitution of Maine and require the following legislation as
immediately necessary for the preservation of the public peace, health and safety; now,
therefore,

11 Be it enacted by the People of the State of Maine as follows:

12 Sec. 1. Adjustment of salary schedules for fiscal year 2013-14. Effective at 13 the beginning of the pay week commencing closest to September 1, 2013, the salary 14 schedules for the Judicial Department employees in the administrative services 15 bargaining unit, the supervisory services bargaining unit, the law enforcement bargaining 16 unit and the professional services bargaining unit and employees referred to in section 3 17 of this Act must be adjusted upward by 1%.

- **Sec. 2. Adjustment of salary schedules for fiscal year 2014-15.** Effective at the beginning of the pay week commencing closest to July 1, 2014, the salary schedules for the Judicial Department employees in the administrative services bargaining unit, the supervisory services bargaining unit, the law enforcement bargaining unit and the professional services bargaining unit and employees referred to in section 3 of this Act must be adjusted upward by 1%.
- **Sec. 3. Other employees; similar and equitable treatment.** Employees of the Judicial Department who are excluded from collective bargaining pursuant to the Maine Revised Statutes, Title 26, section 1282, subsection 5, paragraphs C, D, E, F and G must be given treatment similar and equitable on a pro rata basis to that given employees covered by the collective bargaining agreements.
- 29 Sec. 4. Costs to General Fund. Costs to the General Fund must be provided in 30 the Salary Plan program, General Fund account in the Department of Administrative and 31 Financial Services in the amount of \$205,932 for the fiscal year ending June 30, 2014 and 32 in the amount of \$420,375 for the fiscal year ending June 30, 2015 to implement the economic terms of the collective bargaining agreements made between the Judicial 33 Department and the Maine State Employees Association for the administrative services 34 35 bargaining unit, the supervisory services bargaining unit, the law enforcement bargaining 36 unit and the professional services bargaining unit and for the costs of those Judicial 37 Department employees referred to in section 3, who are excluded from collective bargaining pursuant to the Maine Revised Statutes, Title 26, section 1282, subsection 5. 38

1 Sec. 5. Contingent effective date. This Act takes effect only upon ratification of 2 the collective bargaining agreements made between the Judicial Department and the 3 Maine State Employees Association for the administrative services bargaining unit, the 4 supervisory services bargaining unit, the law enforcement bargaining unit and the 5 professional services bargaining unit tentatively agreed to as of July 9, 2013.

6 **Emergency clause.** In view of the emergency cited in the preamble, this 7 legislation takes effect when approved.

SUMMARY

9 This bill authorizes funding of the collective bargaining agreement reached by the 10 Judicial Department and the 4 bargaining units representing Judicial Department 11 employees.

Fiscal Detail and Notes

This bill authorizes a 1% salary increase effective September 1, 2013 and a 1% salary increase effective July 1, 2014 for certain employees in the Judicial Department. The General Fund cost is estimated to be \$205,932 in fiscal year 2013-14 and \$420,375 in fiscal year 2014-15 to be funded by transfers from the Salary Plan program within the Department of Administrative and Financial Services.
