A. A diving tender licensed under this section may not sell sea urchins or scallops unless the person:

(1) Sells sea urchins or scallops to a purchaser who holds a valid wholesale seafood license with a sea urchin buyer's permit or a valid wholesale seafood license with a sea urchin processor's permit or a valid retail seafood license or sells scallops to a purchaser who holds a valid wholesale seafood license or a valid retail seafood license; and

(2) Provides to the purchaser the name and license number of the license holder with whom the person was engaged when the sea urchins or scallops were harvested.

B. A holder of a <u>wholesale seafood license</u>, a wholesale seafood license with a sea urchin buyer's permit or a wholesale seafood license with a sea urchin processor's permit or a retail seafood license who purchases scallops or sea urchins from a diving tender licensed under this section may not purchase the sea urchins or scallops except by check or cashier's check unless there is a written receipt associated with the transaction, and the holder of <u>a wholesale seafood license</u>, a wholesale seafood license with a sea urchin buyer's permit or a wholesale seafood license with a sea urchin processor's permit or a retail seafood license who purchases scallops or sea urchins from a licensed diving tender shall report the information provided by the person under paragraph A, subparagraph (2) in accordance with section 6173.

4. Supplemental license. A supplemental license must be obtained for each additional establishment or vehicle.

5. Eligibility. The marine worm dealer's license is a resident license.

6. Fee. The fee for a marine worm dealer's license is \$64 and the fee for a supplemental license is \$26.

7. Violation. A person who violates this section commits a civil violation for which a forfeiture of not less than \$100 nor more than \$500 may be adjudged.

A holder of a license required under this section when buying <u>marine worms</u> directly from a harvester may buy only from a harvester who possesses a marine worm digger's license under section 6751, and when buying green crabs from a harvester may buy only from a harvester who possesses a commercial green crab only license issued under section 6808. The harvester shall make the marine worm digger's license or commercial green crab only license available for inspection upon the license holder's request.

- SUMMARY
- 24 This amendment adds an emergency preamble and clause to the bill.

This amendment amends a provision in the bill to clarify that a conviction of a crime is considered a conviction and an adjudication of a civil violation is considered an adjudication during the pendency of appeal.

The amendment lowers the license surcharge for a nonresident lobster and crab landing permit beginning in 2014.

The amendment clarifies that licensed diving tenders may sell scallops to a wholesale
 seafood license holder regardless of whether the license holder holds a sea urchin buyer's
 or processor's permit.

The amendment adjusts the amount of shell scallops permitted in the personal use exemption in the scallop licensing laws from one bushel to 1 1/2 bushels.

The amendment allows the holder of a marine worm dealer's license and a wholesale seafood dealer's license to purchase and sell green crabs without a green crab only license. It also authorizes a holder of a Class I, Class II, Class III, or student lobster and crab fishing license to fish for or take green crabs without a commercial green crab only license and to sell green crabs without a commercial green crab only license.

Finally, the amendment sets February 1st as the deadline for issuing an elver dealer's license for the current licensing year. Currently, the law sets February 1st of the current year as the deadline for issuing an elver dealer's license for the following licensing year.

#### **Fiscal Note**

Minor revenue decrease - Other Special Revenue Funds

#### **Fiscal Detail and Notes**

The bill lowers fiscal year 2014, fiscal year 2015 and fiscal years 2016 through 2018 surcharges for nonresident lobster and crab landing permits from \$425 to \$160.75, \$850 to \$320.75 and \$1,275 to \$480.75 respectively. This bill lowers fees for commercial green crab only licenses from \$38 to \$10 for residents and from \$76 to \$20 for nonresidents. The bill allows the holder of a marine worm dealer's license to buy, possess, ship, transport or sell green crabs for non-human consumption purposes without a commercial green crab only license. The Department of Marine Resources has indicated that very few of these permits and licenses are currently sold and that lowering the price should increase the number sold, offsetting most of the fee reductions.
